First Place.....Blue

Third Place.....Yellow

Qualifying Score.....Dark Green

A New Title rosette will be awarded to all dog and handler teams finishing a title.

High in Trial & High Combined in Trial

Only teams who participate in the same difficulty level for all elements offered (Container, Interior, Buried), and qualify in each are eligible to win **High in Trial**. One High In Trial winner is chosen for each difficulty level; there is no separate High In Trial for the Novice A and Novice B sections. The High in Trial is determined by adding the team's faults across the elements. If there is a tie based on faults, then the team's times across the elements will be summed and the faster-finishing team will win. **High Combined in Trial** is the same as above including the HD element. **High In Trial Jr Handler-** Awarded to the Junior who qualifies across the most elements with the fewest faults. If two Juniors are tied based on faults, then the faster-finishing Junior will be awarded High In Trial Jr. Teams winning High In Trial will earn rosette.

All ribbons must be claimed on the day of the trial; none will be mailed. If you must leave, please a stamped self-addressed envelope at check in.

All exhibitors should obtain a copy of the Regulations for Scent Work Trials by downloading them from the American Kennel Club website.

SAFETY, BEHAVIOR and LIABILITY

By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Progressive Dog Club of Wayne County, Inc. and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. Progressive Dog Club of Wayne County, Inc. reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Progressive Dog Club of Wayne County, Inc., or any official thereof.

REFUNDS

No **entry fee** will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

Dogs pulled after closing because of **injury or other medical condition** are eligible for a refund (minus AKC fees) with a veterinary note. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial

Bitches in season will be refunded the full entry fee. Veterinary notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

EXHIBITOR CHECK-IN: At check-in you will receive your armband number. Once the time and location for check-in is determined all exhibitors will be notified by email.

Exhibitors MUST check-in EACH day they are entered.

"Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations." Additionally, clubs should include any specific local or state health requirements; for example, proof of rabies vaccination.
